



Assumption of Risk Statement For Temporary Volunteers

I, _____, in consideration of volunteering for the Common Ground Relief, Inc., hereby agree to exercise due care and attention. Particularly in respect to the following:

1. I will follow all instructions of Common Ground Relief supervisory personnel.
2. In conjunction with the responsibilities related to my volunteer service, I will restrict myself to areas designated by Common Ground Relief supervisory personnel.
3. I am aware of the physical hazards (including, but not limited to potential exposure to venomous caterpillars and snakes, alligators, biting insects and maladies related to the performance of physical labor), which I may be exposed to. I will maintain a suitable level of fitness as necessary to perform the essential functions of my volunteer duties, and will not report to duty under the influence of alcohol or illegal substances, and will not consume any such substances while volunteering with Common Ground Relief.
4. I will exercise proper and safe use of all Common Ground Relief equipment; I will obtain thorough operating instructions, and will carefully inspect all equipment to ascertain its integrity prior to each use.
5. I will report any potential safety hazards, incidents or accidents immediately to the appropriate Common Ground Relief personnel.
6. I understand that there is an inherent degree of risk in working in wetland areas, both forested and grass-dominated, for purposes of education and restoration projects.
7. I understand that the above list is in no way all inclusive of possible risks associated with volunteer services at Common Ground Relief.



Waiver of Responsibility

With full knowledge of all statements listed on page one, I accept and assume any and all risk of damage which may occur. In assuming such risk, I the undersigned, hereby release the Common Ground Relief agency, employees, volunteers, and owners of planting sites from any and all liability for loss, damage or injury to myself or to any personal property which may be incurred through participation in the Common Ground Relief's Volunteer Program.

It is agreed that neither Common Ground Relief, nor any of its officers or agents shall be in any way liable for any loss, damage, death, or injury of any kind to myself or any person, vehicle or other property arising out of or connected with the presence of myself as a Common Ground Relief Volunteer whether such injury, loss, death, or damages is claimed to be caused by the condition of said premises or any act of negligence or omissions Common Ground Relief or its agents or servants or from any cause, and the undersigned volunteer hereby specifically assumes all such risk fully completely.

The undersigned volunteer hereby agrees to indemnify, save and hold harmless that Common Ground Relief and its respective officers, employees, and agents from any and all liabilities, claims and demands for damages, injuries, deaths, or losses or costs or expenses of any kind resulting from or arising out of any claim resulting from or arising out of the presence of said volunteer on said premises of Common Ground Relief's education programs or planting sites, and volunteer agrees to defend any claim or suit which may arise from the foregoing and to pay all attorney fees and cost thereof.

The undersigned volunteer agrees not to sue and specifically assumes all such risk that is inherent in the activities undertaken by the volunteer in the course of participating in Common Ground Relief projects.
